2. Pay the **refundable holding fee of Rs. 700 (INR) by 10th June 2016 before 5:00 PM.** The holding fee will be returned to the candidates on the final day of the Summer School. In case, candidates fail to join the Summer School, the fee will be forfeited. Instructions on how to pay the holding fee has been provided below.
3. **Make travel arrangements** as soon as possible to ensure that you arrive in Ahmedabad by 20th June (Morning before 9:00). As indicated on the website, travel reimbursements up to Rs 2000 on actuals will be given to all participants.
4. As indicated on the website, **accommodation** for participants will be provided in regular student hostels free of cost (without AC or Cooler). You are welcome to explore other stay options in the area. We will provide information on nearby hotels on the website.
5. As indicated on the website, all participants will be given an **allowance of Rs. 150 per day** for 12 days towards partial defrayment of food expenses. Participants will find several canteens and food kiosks on campus.
6. Please carry (hard copy) your online registration form receipt (SSF–App ID) copy & college ID Proof at the time of registration on 20th June (Morning 9:00 AM)
