- For identification purpose, each candidate should keep his PAN Card (only) for verification. The PAN Card number needs to be entered in the application form at appropriate place.
- No manual / Paper / Email application will be entertained.
- Read the instructions carefully and fill-in the online application form giving accurate information about your candidature.

**Selection Process:**

- Eligible candidates shortlisted based on submitted online application will have to appear for selection process conducted at IITGN premises.
- The selection process may comprise of a written test followed by personal interview. IITGN reserves all the rights, not to call an applicant for interview, without assigning any reason.
- The decision of the selection committee formed by IITGN is final and binding to all. No queries related to the same shall be entertained.
- Fulfillment of “Minimum Qualifications” and “Eligibility” does not entail a call for interview. Only shortlisted applicants shall be called for written test and/or interview.
